IMPORTANT NOTICE TO GUIDES

1. The Pyramid Lake Paiute Tribal Regulations Brochure (Section 21) requires all persons providing fishing guide and boat charter services within the exterior of the Reservation to complete a Pyramid Lake Fishing Guide and Boat Charter Application.
2. All applicable sections of the applicaton must be complete and legible. NO "pending", "unknown" blanks will be accepted.
3. Applications **must** be received by the Pyramid Lake Paiute Tribe by **July 26, 2024**. Forms are reviewed by the Ranger Supervisor prior to submission to Tribal Council for final determination on **August 2, 2024**. Applications will **NOT** be accepted after **July 26, 2024, NO EXCEPTIONS**.
4. Guides will be notified via email within 7 days of final determination with permits mailed within 7-10 days.
5. Permits are valid for the fishing season running October 1 through September 30 of the following year.
6. There is only one person per guide permit or boat charter. Permit is non-transferable.
7. There are no sub-guides, all guides **MUST** have a valid Pyramid Lake Fishing Guide/Boat Charter Permit.
8. Fishing Guides and Boat Charters must keep the validated permit in their possession while providing guiding services.
9. **Per Pyramid Lake Paiute Tribal Council, May 19, 2022, Fishing Guides and Boat Charters are required upon approval and prior to providing guiding services on Pyramid Lake, apply for a business license law the PLPT Business License & Permitting Ordinance Title III, Chapter 17. Business License Ordinance & Application located on-line at www.plpt.nsn.us/departments/Business**

ITEMS GUIDES MUST HAVE ON THEIR PERSON WHILE GUIDING

A fishing guide or boat charter should be able to present all documents required for the permit upon request by a Pyramid Lake Paiute Ranger or Tribal Police Officer.

- o A current Pyramid Lake Paiute Tribe Fishing Guide/Boat Charter Permit. Permit will be laminated with a tribal logo embossed.
- o A valid photo identification card.
